1) Call to Order

2) Approval of April, 2007 General Meeting Minutes
Meeting minutes were approved.

3) Financial Report – Keith Reynolds
Keith Reynolds provided the financial report. \$75 was paid to the Information Network of Arkansas for background check setup. \$209 is currently pending payment for background checks that have been processed.

4) Camp Committee Report – Steve Boyles
Steve Boyles provided an update on the Camp. Steve is currently lining up players from the Twisters to attend this year's camp. The committee is investigating the possibility of having the camp on a Friday evening at the high school stadium, to avoid the heat that generally puts a damper on the camp experience.

5) Opening Day Ceremonies Committee Report – Darren Collins
(or Closing Awards Ceremony)
Discussion was held over the pros and cons of having an opening day ceremony at the beginning of the season, versus an awards ceremony at the end of the season. The general consensus was that both would be nice. The opening day ceremony is a large fundraiser for the CYFA and funds collected will cover expenses for background checks this year. The awards ceremony will be an opportunity for the CYFA to give back to the kids and sponsors. Medallions will be presented at the ceremony to all players and sponsors will be recognized and presented their sponsor plaques. This should also be a benefit to parents as they will not have to incur the expense of trophies at the end of the season.

6) Executive Committee Report on Coaching Selections – Greg Sled

Coaches assigned to the point were named, and by order of tenure, were allowed to name their team mascot. Coaches new to a particular league drew for the team they would be taking over. Coaches will be responsible for obtaining their sponsor this year, and the previous year's sponsor for their team was provided to the coach.

The Association voted and awarded Unlimited Screen Printing of Cabot the contract to provide our uniforms again this year. A vote was taken by the Association on the brand of pants and jerseys we will use. It was agreed that Wilson jersey was the best value. A vote was also taken to set this year's dues at \$65, a \$5 increase over last year's fee. This will cover remaining additional costs for the year, including the additional (third) referee that will be on the field for the Pro and Semi-Pro leagues, and the Wilson jersey's which were approximately \$2 more than the second option. Insurance will be shopped again in good faith to ensure that we are getting the best value for our dollar.
