- 1) Call to Order

- 2) Approval of May, 2007 General Meeting Minutes  
Meeting minutes were approved.
- 3) Financial Report – Keith Reynolds  
Keith Reynolds provided the financial report. \$42 was paid to establish a post office box for the CYFA. The current funds balance is \$7951.25.
- 4) Camp Committee Report – Steve Boyles  
Steve Boyles provided an update on the Camp. Steve is currently lining up players from the Rhinos to attend this year's camp. Water is still the primary need for the camp. A motion was made a passed unanimously to set this year's camp fee at \$25.
- 5) Opening Day Ceremonies Committee Report – Darren Collins

- 6) Sponsor Updates

  - B) Facility Improvement Request to Parks & Rec.  
Greg Sled initiated a conversation with the Cabot Parks and Rec to find out what process we need to follow to request improvements to the football complex. A lengthy discussion was held to determine current needs and priorities. Bleachers and canopies for shade were on top of the list. A motion was made and passed instructing a letter to be written to Parks and Rec requesting funding assistances for these improvements.
  - C) Mid-Season Tournament  
The possibility of bringing back the Cabot Clash mid-season tournament during the weekend of Cabot Fest was discussed. It was agreed that it was a good idea, and will be looked into further for planning.
  - D) Coaches Clinic

A coaching clinic has been scheduled for all coaches and assistant coaches with staff from the junior high. The clinic will be held at the Panther fields house.
